#### **EMERGENCY PREAMBLE**

WHEREAS, orders passed by the Brewer City Council do not become effective until five days after approval unless such orders contain emergency preambles; and

WHEREAS, the closing date for signing the lease falls within the five day period; and

WHEREAS, these facts create an emergency within the meaning of the Charter, Code and Ordinances of the City of Brewer and require that the following order become effective immediately upon its approval to protect the public health, common welfare and safety of the citizens of Brewer; and

WHEREAS, the City has been notified that the ice arena located at 90 Acme Road in Brewer is being sold before the end of September, 2013, by Delta Hockey, LLC to Penobsco Hockey, Inc.; and

WHEREAS, as a part of the purchase of the ice arena, Penobsco Hockey, Inc. wants to assume the Lease between the City of Brewer and Delta Hockey, LLC dated May 2, 2002; and

WHEREAS, Section 17.2 of the May 2, 2002 Lease between the City of Brewer and Delta Hockey, LLC allows the Lease to be freely assigned during the initial term and any extensions thereof; and

WHEREAS, the City is fully in favor of Penobsco Hockey, Inc. assuming the Lease upon its purchase of the ice arena; and

WHEREAS, Penobsco Hockey, Inc. has represented to the City that it will vastly improve the ice arena by making the improvements set forth on Exhibit A, attached hereto and made a part hereof, within one (1) year of its acquisition of the ice arena; and

WHEREAS, Penobsco Hockey, Inc. has requested that it be given relief from the rental obligation it is assuming under the May 2, 2002, Lease between Delta Hockey, LLC and the City of Brewer; and

WHEREAS, the City Council believes it is in the best interest of the citizens of the City of Brewer to allow Penobsco Hockey, Inc. to make the improvements set forth on Exhibit A to better serve its citizens, the hockey community within the City of Brewer and beyond;

NOW, THEREFORE, BE IT ORDERED that the City of Brewer, acting through its City Council, supports Penobsco Hockey, Inc.'s assumption of the May 2, 2002, Lease between Delta Hockey, LLC and the City upon its purchase of the ice arena located at 90 Acme Road in the City of Brewer; and

FURTHER, BE IT ORDERED Penobsco Hockey, Inc. agrees to make the improvements set forth on Exhibit A, attached hereto and made a part hereof; and

FURTHER BE IT ORDERED that in exchange for Penobsco Hockey, Inc. making the improvements set forth on Exhibit A within one (1) year of its acquisition of the ice arena, the City agrees to amend the Lease pursuant to Section 22.1 as follows:

- (a) The rental obligations from Penobsco Hockey, Inc. to the City of Brewer for the 2013-2014 lease year will be forgiven in its entirety;
- (b) The rental obligation from Penobsco Hockey, Inc. to the City of Brewer for the 2014-2015 lease year will be reduced by fifty percent (50%); and
- (c) The balance of the terms and conditions of the Lease dated May 2, 2002, between Delta Hockey, LLC and the City of Brewer will remain in full force and effect, unless otherwise amended in writing by the City of Brewer and Penobsco Hockey, Inc.; and

FURTHER BE IT ORDERED, that the City Manager, or his designee, is hereby authorized to take any and all actions and to sign any and all Lease amendments consistent with the terms and conditions of this City Council Order that has been approved as to form by the City Solicitor, or some other attorney representing the City of Brewer.

#### EXHIBIT A

#### List of Improvements for the Penobsco Ice Arena

The improvements are listed by priority as what needs to be done first and is an immediate need. These items are scheduled for the first year of operation. Depending on scheduling, etc., we may be able to add some other additional items:

- 1. Some minor plumbing repairs to shower/restroom facilities/tile both shower stalls between the locker rooms
- 2. Remodel locker rooms: Ceilings/Painting/Benches/Repairs to Zamboni Room Door

- 3. Extensive cleaning/sanitizing/mold remediation in locker rooms and showers and extensive painting in these areas and common areas/install false walls behind bleachers and above the office area for overall appearance improvement
- 4. New Zamboni Ice Resurface Machine (possibly a good used one) and repair the existing machine to be used for a back up
- 5. Repairs to existing Olympia Unit to be used as a backup
- 6. Have ABM Mechanical Services evaluate the Ice Chiller Plant for repairs if they think the unit is worth repairing or replacement. As of 9/23 and as per the Purchase & Sale Agreement, Roger Theriault has hired ABM to get the 2<sup>nd</sup> Compressor up and running and to install 2 more cooling fans. After the closing, we will have ABM Mechanical Services return to completely evaluate the unit and have them get the remaining cooling fans replaced and any other additional repairs they deem necessary if indeed the unit can be salvaged.
- 7. Miscellaneous repairs to door closures and general cosmetics
- 8. Have the fire sprinkler system recertified
- 9. Remodel main office area/painting/built in counter desk areas/ceiling

#### City of Brewer High School District Financial Statement Regarding Borrowing for School Renovation Project

As of the referendum date, the total amount of bonds of the City of Brewer High School District outstanding and unpaid is \$44,060,486 of which \$34,741,171 is principal and \$9,319,315 is interest. This District has \$0 in bonds that are authorized but unissued. The total general obligation to be assumed if the article authorizing this borrowing is ratified by the voters is \$2,691,136. The total debt service costs of the Project will vary depending on the prevailing interest rates at the time the bonds are issued. The total estimated debt service is \$4,111,027 of which \$2,691,136 is principal. Estimated interest of 4.79% on the bonds over 17 years is \$1,419,891.

The validity of the bonds and of the voters' ratification of the bonds may not be affected by any errors in the estimate made pursuant to the above statement. If the actual amount of the total debt service for the bonds varies from the estimate, the ratification by the electors is nevertheless conclusive and the validity of the bond issue is not affected by reason of the variance.
